

## Politics

Limited Liability Company "Bystro Mani Plus" in the field of personal data processing

### 1. General provisions

1.1 in order to fully comply with the norms of the current legislation of the Republic of Kazakhstan, the limited liability company (hereinafter referred to as the operator) considers compliance with the principles of legality, honesty and confidentiality in the processing of personal data, as well as ensuring the security of their processing to be its most important tasks.

1.2 these regulations for the protection of personal data of citizens (hereinafter - the regulations) have been developed in accordance with the legislation

1.3 the policy sets out the procedure for collecting, processing, storing, combining, transferring and any other use of personal data that the Operator may receive about users of the website

1.4 this policy applies to all employees of the operator who have access to personal data.

### 2 basic concepts used in politics

2.1 for the purposes of this policy, the following basic terms apply:

2.1.1 automated processing of personal data - processing of personal data by computer equipment;

2.1.2 blocking of personal data-actions to temporarily cease the Collection, Collection, modification, modification, addition, use, dissemination, depersonalization and destruction of personal data;

2.1.3 website - a collection of graphic and information materials, as well as computer programs and databases, ensuring their availability on the Internet at a network address <http://fastloan365.ph/>;

2.1.4. Personal data Information System-a set of information technologies and technical means contained in personal data databases and ensuring their processing;

2.1.5. Depersonalization of personal data-actions as a result of which it is not possible to determine whether personal data belong to the personal data subject;

2.1.6 processing of personal data-activities aimed at collecting, storing, modifying, changing, adding, using, disseminating, depersonalizing, blocking and destroying personal data;

2.1.7. Operator - public authority, natural person and (or) legal person who is the operator of the database containing personal data, collecting, processing and protecting personal data;

2.1.8. Personal data - information relating to or specific to a person.

2.1.9. User - any person visiting the website;

2.1.10. Sharing of personal data-actions aimed at disclosing personal data to a specific person or a certain circle of people;

2.1.11. Dissemination of personal data - activities resulting in the transfer of personal data, including through the media or the provision of personal data in any other way.

### 3. Classification of personal data and data subjects

3.1 the Operator does not process personal data relating to race and nationality, political views, religious and philosophical beliefs, health status, intimate life and criminality of natural persons.

3.2 the Operator processes personal data of the following categories of personal data subjects:

3.2.1. natural persons who perform work consisting in the provision of services and have concluded a civil law contract with the operator;

3.2.2. natural persons who are users of the operator's website and the services provided on it;

3.2.3. natural persons who are not customers of the operator, who have concluded or intend to conclude a civil law agreement with the operator;

3.2.4. natural persons whose personal data have been made publicly available by the operator, and their processing does not violate their rights and complies with the requirements set out in the legislation on personal data;

3.2.5. other natural persons who have consented to the processing of their personal data by the operator.

### 4. Legal basis for processing personal data

4.1 the Operator processes the user's personal data only if they are filled in and / or sent by the user himself / herself through special forms located on the site. By completing the relevant forms and / or sending your personal data to the operator, you agree to this policy.

### 5. Principles, purposes, content and methods of personal data processing

5.1 the Operator in its activities ensures compliance with the principles of personal data processing

5.2 the Operator collects and processes personal data for the following purposes:

5.2.1. providing personal data subjects with access to the services of the website in order to select a banking product;

5.2.2. conclusion of any agreements with the subject of personal data and their further implementation;

5.2.3. information interaction with the personal data subject by any means (including by e-mail, telephone, text messages, social networks, mail or in person) to provide information materials and other information with due regard to the need to obtain the consent of the personal data subject to the distribution of information in accordance with the requirements of applicable law.

5.2.4. provide data subjects with access to the services, information and materials of the website;

5.2.5. increasing the usability of the website and improving its services;

5.2.6. improving the quality of personal data provided by the operator's partners;

5.2.7. consideration by the operator's partners of the possibility of concluding / performing civil law contracts with the person to whom the personal data relate.

5.3 the Operator has established the following conditions for the termination of the processing of personal data:

5.3.1. the storage of personal data in a form that makes it possible to identify their subjects takes place only for the period during which the Operator maintains a permanent relationship with the personal data subject and/or the personal data are necessary for the implementation of legally justified purposes for which there is a valid legal basis.

5.3.2. termination of the processing of personal data occurs in the event of loss of necessity for the implementation of the purposes of processing personal data - within 30 days.

5.3.3. the processing of personal data is stopped if the data subject or his legal representative provides information confirming that the personal data were obtained unlawfully or are not necessary for the indicated purpose of processing - within 7 days.

5.3.4. termination of the processing of personal data occurs when it is not possible to ensure the legality of the processing of personal data - within 7 days.

5.3.5. the termination of the processing of personal data occurs in the event of the withdrawal by the data subject of consent to the processing of personal data, if the retention of personal data is no longer necessary for the purposes of the processing of personal data - within 10 days.

5.4 the processing of personal data by the operator includes the collection, collection, storage, modification, modification, replenishment, use, dissemination, depersonalization, blocking and destruction of personal data.

5.5 the Operator does not process biometric personal data (information that characterizes the physiological and biological characteristics of a person, on the basis of which it is possible to establish his identity).

5.6 the Operator makes a cross-border (on the territory of a foreign country to a foreign state body, a foreign natural person or a foreign legal person) transfer of personal data.

5.7 the Operator processes personal data in an automated manner.

5.8 the security of personal data processed by the operator will be ensured through the implementation of legal, organizational and technical measures necessary to fully comply with the requirements of applicable legislation in the field of personal data protection.

5.9 the Operator ensures the security of personal data and takes all possible measures to prevent unauthorized persons from accessing personal data.

5.10 if any inaccuracies in personal data are detected, the user may update them by sending the operator a notification to the operator's e-mail address with the note "updating personal data".

5.11 the user may withdraw his consent to the processing of personal data at any time by sending a notification to the operator

## 6. Rights of data subjects

6.1 the personal data subject has the right to receive information about the processing of his personal data by the operator.

6.2 the personal data subject has the right to request the operator to amend and supplement his / her personal data if there are grounds confirmed by relevant documents; to block his / her personal data in

case of receiving information about a violation of the terms of collection and processing of personal data; to destroy his / her personal data, the collection and processing of which was carried out in violation of the legislation of the Republic of Kazakhstan, as well as in other cases specified in this law and other regulatory legal acts of the Republic of Kazakhstan.

6.3 the right of a data subject to access his or her personal data may be restricted in accordance with the personal data Act, including where the access of a data subject to his or her personal data infringes the rights and legitimate interests of third parties.

6.4 in order to exercise and protect their rights and legitimate interests, the data subject has the right to contact the operator. The Operator considers all appeals and complaints of data subjects, carefully examines the facts of violations and takes all necessary measures to eliminate them immediately, punish the perpetrators and resolve disputes and conflicts in pre-trial proceedings.
